- **Individual:** Ethical consideration nudge an individual to follow ethics in her lifestyle. For example, many people have been inspired by the teachings of Mahatma Gandhi, who emphasized the importance of nonviolence, truth, and compassion in all actions.
 - Further, they have tried to apply these teachings in their own ethical development by striving to be honest and kind in their interactions with others, and by seeking nonviolent solutions to conflicts.
