Why in News?

Recently, the [Jammu and Kashmir](#) administration unveiled the **Jammu and Kashmir Film Policy, 2024** to incentivize film shooting in the region

Key Points

- The Jammu and Kashmir Film Policy, 2024 was unveiled on 1st August by J&K [Lieutenant Governor](#) in [Srinagar](#).
 - The policy aims to boost both **domestic and international film production** in Jammu and Kashmir (J&K).
 - The policy includes plans for **high-impact infrastructure and financial incentives** to enhance the attractiveness of filming in J&K.
- **Access to Locations:** The policy opens up scenic locations, including previously restricted areas closer to the [Line of Control \(LoC\)](#) like **Gurez, Machil, and Tangdhar**, for film shooting.
 - Traditional tourist hotspots such as **Gulmarg and Pahalgam** remain accessible for filmmakers.
- **Administrative Mechanism:**
 - The **Kashmir Film Development Council (JKFDC)** has been established as an online **single-window** mechanism for facilitating film production.
 - A '**location permission committee**' and a '**script screening committee**' will review applications. Final approvals are expected within two to four weeks.
- **Historical Context:**
 - Kashmir was a popular filming location until the 1950s, with significant movies like **"Jungle" (1961)** and **"Jab Jab Phool Khile" (1965)** showcasing its beauty.
 - The region's filming opportunities were restricted due to security concerns until recent peace agreements.

Maa Nanda - Sunanda Mahotsav | Uttarakhand | 09 Sep 2024

Why in News?

Recently, Uttarakhand CM virtually inaugurated the **Maa Nanda-Sunanda Mahotsav, 2024**, in Nainital highlighting the festival's role in connecting people with their cultural roots.

Key Points

- **Maa Nanda-Sunanda Mahotsav:**
 - Celebrated in remembrance of the goddesses **Nanda and Sunanda** during the

Nandashtami festival in the Kumaon region of Uttarakhand every September.

- Observed in locations such as **Almora, Nainital, Kot Along, Bhowali, and Johar.**
- CM announced **2nd September** as **Bugyal Conservation Day** to protect alpine meadows, describing them as the Himalayas' '**precious heritage**'.

Bugyals

- Bugyals are high-altitude alpine meadows found in Uttarakhand.
 - These meadows are characterized by their lush greenery and are situated above 3,000 meters (10,000 feet) in elevation.
- **Ecological Significance:** Bugyals are crucial for the region's biodiversity, supporting a range of flora and fauna.
 - They serve as grazing grounds for livestock and are vital for maintaining ecological balance.
- **Popular Bugyals in Uttarakhand:**
 - **Dayara Bugyal:** Known for its expansive meadows and stunning views.
 - **Bedni Bugyal:** Famous for its scenic beauty and as a trekking destination.
 - **Auli Bugyal:** Noted for its panoramic views and biodiversity, Auli is nestled amidst the giant snowy peaks of **Nanda Devi, Kamet and Dunagiri.**

Uttarakhand CM Approves Flood Relief Funds | Uttarakhand | 09 Sep 2024

Why in News?

Recently, Uttarakhand CM approved special assistance from the **Chief Minister's Disaster Relief Fund** to **aid businessmen affected by heavy rains** in the [Kedarnath area](#).

Key Points

- The funds are allocated to compensate businessmen affected by damage to pedestrian and motor roads from **Linchauli to Sonprayag** due to heavy rains.
- The approved amount will be used specifically for those affected by the damage on **31st July**.
- Payments will be made through **e-banking or demand drafts**, with details of beneficiaries to be maintained at the district level.
- Approximately 17,000 people were evacuated from disaster-affected areas in [Rudraprayag district](#).

CM Relief Fund (CMRF)

- CMRF is an emergency assistance scheme for granting relief to deserving families and individuals affected by natural calamities like [floods](#), [droughts](#), [earthquakes](#) etc. or any other similar calamities.

Jharkhand Lowers Age Limit for Maiyan Yojana | Jharkhand | 09 Sep 2024

Why in News?

Recently, the Jharkhand cabinet approved a reduction in the age limit for the [Mukhyamantri Maiyan Samman Yojana \(MMSY\)](#).

Key Points

- The minimum age limit for the Mukhyamantri Maiyan Samman Yojna (MMSY) has been reduced from **21 to 18 years**, aiming to extend the benefits to an additional 800,000 women.
- **MMSY:** The scheme was launched on **3rd August, 2024**. Under the scheme, Rs 1,000 will be given to eligible women from families living below the poverty line.
 - A total of Rs 12,000 will be sent to the bank accounts of all eligible women every year through [Direct Benefit Transfer Scheme](#).

Direct Benefit Transfer Scheme

- **Aim:** It has been visioned as an aid for simpler/faster flow of information and funds to the beneficiaries and to **reduce the fraud** in the delivery system.
- **Implementation:** It is a mission or an initiative by the government of India started on **1st January 2013** as a way to reform the government delivery system.
 - **Central Plan Scheme Monitoring System (CPSMS)**, the earlier version of the [Public Financial Management System \(PFMS\)](#), of the Office of [Controller General of Accounts](#), was chosen to act as the common platform for routing of the Direct Benefit Transfer.

Savitribai Phule Kishori Samridhi Yojana

- This scheme was started in the state with the aim of emphasising on [girl education](#), ending [child marriage](#) and [women empowerment](#).
- Under this scheme, the state government is giving assistance of a total of **Rs 40,000** to adolescent girls for good education.

Gorakhpur Sainik School Inaugurated | Uttar Pradesh | 09 Sep 2024

Why in News?

Recently, the [Vice President](#) inaugurated the [Gorakhpur Sainik School](#), praising its facilities and highlighting its importance for education in **eastern Uttar Pradesh**.

Key Points

- **Gorakhpur Sainik School Details:**
 - 1st Sainik School in Eastern Uttar Pradesh.
 - 2nd Sainik School managed by the **Uttar Pradesh Sainik School Society**.
 - 5th Sainik School in Uttar Pradesh; others are in [Jhansi](#), [Amethi](#), [Mainpuri](#) (run by Defence Ministry) and [Lucknow](#) (run by Uttar Pradesh government).
- The Vice President also visited **Gorakhdham temple in Gorakhpur**.

- The Gorakhdham Temple in Gorakhpur is dedicated to Guru Gorakshanath, a prominent saint of the Nath sect, and serves as a major pilgrimage site and spiritual center.
- The temple features traditional [Hindu architectural](#) elements with a prominent **central dome and detailed interiors**.

Sainik Schools

- Sainik Schools are residential institutions offering public school education and are affiliated with the [Central Board of Secondary Education \(CBSE\)](#), New Delhi.
- **Funding:** These schools receive financial support from both **Central and State governments**.
- **Establishment:** Launched in **1961**, Sainik Schools were designed to prepare students academically, physically, and mentally for entry into the **National Defence Academy**.
- **Governance:** They are managed by the **Sainik Schools Society under the Ministry of Defence**, established under the [Societies Registration Act XXI of 1860](#).

India Boosts Military Diplomacy with Tri-Service Drills | Jammu & Kashmir | 09 Sep 2024

Why in News?

Recently, India has ramped up its [military diplomacy](#) through a series of high-profile joint exercises, engaging with nations across the globe in back-to-back drills involving all three services.

Key Points

- [Yudh Abhyas \(India-U.S. Army Exercise\)](#) set to begin on **9th September, 2024**, in **Rajasthan** with one of the largest U.S. contingents, including 600 personnel. India is evaluating **Stryker vehicles and Javelin ATGMs (Anti-Tank Guided Missiles)** for potential procurement.
- [Tarang Shakti \(Indian Air Force Multilateral Exercise\)](#), Phase-II is underway in **Jodhpur from 1st September to 14th September, 2024**, with **8 participating** nations and 17 others observing. The U.S. **A-10 Thunderbolt II is flying in Indian airspace for the first time**.
- [Malabar Naval Exercise](#) Scheduled for **October 2024 off Visakhapatnam**, featuring **India, Australia, Japan, and the U.S.** as key participants, enhancing naval cooperation.
- [Mitra Shakti](#) exercise with Sri Lanka occurred from **12th - 25th August, 2024**. India also participated in the [Khaan Quest peacekeeping exercise in Mongolia](#) (27th July - 9th August, 2024) with 23 nations.
- Russian ships visited Kochi in August 2024, while [INS Shivalik](#) took part in [RIMPAC \(Rim of the Pacific Exercise\)](#) from 27th June - 1st August, 2024. [INS Tabar](#) participated in [Exercise Varuna](#) with France in September 2024.
- For the first time, India deployed the [P-8I](#) maritime patrol aircraft in Europe for **Exercise Varuna**, enhancing operational presence.
- India participated in [Exercise Pitch Black in Australia](#) (12th July - 2nd August, 2024) and [Exercise Red Flag hosted by the U.S.](#) in June 2024, strengthening air force cooperation.
