Introduction

 - **Pro:** This could raise public awareness and put pressure on those involved in the corruption to take action.
 - **Con:** This could result in negative publicity for the government and potentially harm the government official's career, as this will go against the code of conduct of civil servants.
- **Seek Legal Advice and Pursue Legal Action:** I would seek legal guidance to understand the nuances of case and take it further to legal action in court.
 - **Pro:** This could result in legal consequences for those involved in the corruption and potentially prevent further harm to patients.
 - **Con:** This could be a lengthy and costly process with no guarantee of success and it's against my code of conduct and further it will hamper my work responsibility by going to court on regular basis.
- Reach out to other government officials or organizations: I would try to connect with officials from another department/organization to make them aware of wrongdoings in my department.
 - **Pro:** This could result in support from others who share the same concerns and potentially lead to collective action to address the issue.
 - **Con:** There is a risk that others may not be willing or able to help and harm the reputation of health department.

Conclusion

In this case, the most ethical option would be to **report the issue to higher authorities or an anti-corruption agency.** While this option comes with potential risks, such as retaliation against the government official, but as a government official it my duty to prioritize the well-being of the patients who rely on government hospitals for their healthcare needs. It is crucial to take action against corruption in the procurement of medicines to ensure that patients receive the quality healthcare they deserve.
